- Publications in midwifery journals/texts or other professional journals/texts *
- Midwifery book reviews for publication *
- Advisory participation in research projects that impact on care provided to women
- Local “hands on” participation in formal ethically approved research projects that impact on care provided to women
- Journal article peer reviews *

Quality assurance activities

- Conducting clinical audits
- Evidence based policy and guideline development
- BFHI Assessor
- BFHI local coordinator – must be over and above requirements of employment
- Quality Health NZ auditor
- Participation in project user groups that directly impact on midwifery practice

Other activities will be added to the schedule when identified.

Hours guidance

Most activities will be able to have direct hours of engagement attributed to them. Some activities highlighted with an * will include preparation time that is completed by the midwife away from the activity. This time should be included and as a guide it is suggested that it should be a minimum of four hours.

Schedule of professional activities

31 March 2017

Overview

There are many activities that midwives are engaged in on a daily basis that focus on quality improvement in practice and that contribute to the betterment of the Midwifery profession in New Zealand.

Midwives are required to obtain a minimum of eight (8) professional activity hours per annum. In all situations midwives are required to hold formal evidence of engagement in professional activities in their portfolio.

All Midwives are required to reflect on their learning from the professional activity and demonstrate how this has changed their practice.

The following schedule lists the most common activities.



The Midwifery Council

The Midwifery Council is the guardian of professional standards in midwifery. It makes sure midwives meet and maintain professional standards of education, conduct and performance so that they deliver high quality healthcare throughout their careers. The safety of mothers and babies comes first.

Working with colleagues

- Engaging in mentoring as a mentor or mentee. This includes for example MFYP mentoring, rural mentoring, mentoring internationally qualified midwives new to New Zealand, mentoring of colleague in a return to practice programme
- Preceptoring midwifery students in clinical placements
- Preceptoring and supporting orientation of a registered colleague to the work environment
- Unpaid voluntary midwifery practice overseas
- Assisting and assessing other health professionals in their maternity related teaching and learning activities

Midwives must obtain a minimum of eight professional activity hours per annum

Historically attendance at conferences or seminars has been included as professional activity. Changes to recertification programme effective 1/4/17 mean that these are now classified as continuing midwifery education hours.
